She has received training for Online Covert Investigations, Peer to Peer Investigations and Search Warrant Drafting through the RCMP and is a qualified Child Forensic Interviewer. She has also been fortunate enough to attend several conferences and workshops specific to Internet Child Exploitation across North America where ICE investigators, and other agencies committed to the protection of children, are able to network and learn best practices for the always evolving world of the Internet and technology.

RCMP And Enforcement Services

Many presentations of this nature are for law enforcement or schools. Although well intended, the main focus becomes the shock and awe of Law Enforcement to help emphasize the role they are being asked to perform. Other presentations may use select statistics and the fear factor of those tragic days in order to sell a product that will help improve the client's survivability. Most presentations forget to focus on the lessons learned and the solutions that may be staring us in the face. Corporations are sometimes reluctant to even begin this type of training since it ties into the anxiety of the unknown for most since most people are informed of the incidents that have taken place by the media, who will tell you about how many people were hurt or died, it is normally in the headline of the article, but they do not give to the stories of those who survived or how.

That's the missing piece!



This presentation is different. Within it I will help the listener develop and understand their own plan along with realizations of how a company can better prepare for an incident like this long before it is ever a realization. We will do this together and built it around three simple instructions, "Run, Hide, Fight."

This sounds very simple, but understanding the information behind this can help a corporation or an individual build a plan for success. This will not be a "one glove fits all" presentation. It will open questions within yourself and your organizations. It will dispel some myths but will help create guidelines around the development of a good working plan. This presentation is just the beginning of the work we all need to be doing but never understood how to start that journey.

I have delivered this to over 9000 people and have even had people tell me that they were apprehensive to attend the presentation, but "left feeling empowered. I and am looking forward to meeting you all and help you build you plan to succeed.
