### **CIVIL FORFEITURE FUND (CFF)**

On November 15, 2013, Justice and Solicitor General is asking groups to apply to the Civil Forfeiture Fund (CFF).

When the process is complete, \$2.8 million will be allocated to organizations that support crime prevention programs or help vulnerable Albertans. Funding requests can range from \$50,000 to \$500,000 per project for up to two years.

### MP Costas Menegakis applaud's Government's intention to introduce "Quanto's Law"

(Ottawa, Ontario, October 16, 2013) - Richmond Hill MP Costas Menegakis today applauded the government's intention to bring forward "Quanto's Law," legislation to protect law enforcement animals. The announcement was made during the Speech from the Throne delivered October 16 by the Governor General of Canada, His Excellency the Right Honourable David Johnson, to open the second session of the 41st Parliament.

Earlier this year, MP Menegakis had introduced a Private Members' Bill, the *Protection of Law Enforcement Animals Act*. "This Bill will ensure that the innocent animals that aid in our protection, are protected themselves," said MP Menegakis during its introduction in the House of Commons May 29.

As originally proposed, the Bill would amend the Criminal Code to make it an offence to poison, injure or kill a law enforcement animal while it is accompanying a peace officer or public officer engaged in the execution of their duties.

Inspiration for the Bill had come from the circumstances surrounding the tragic death of Brigadier, the Toronto Police Service horse killed in the line of duty in 2006 after the driver of a vehicle struck the horse before fleeing the scene.

"I was touched by constituents who had shared their views with me on the tragic tale of Brigadier," said MP Menegakis. "Many individuals since then have been calling for stronger punishments for those who deliberately injure or kill a service animal. Quanto's Law will honour the memory of Edmonton Police Service dog Quanto, Toronto Police Service horse Brigadier, and other law enforcement animals who have made the ultimate sacrifice in the line of duty. I look forward to its introduction and swift passage through Parliament."



## Who we are

Citizens On Patrol Off-Road (COP-OR)is a not-for-profit group of All Terrain Vehicle (ATV) owners. The group operates under the sponsorship of Marine Riders ATV Club in cooperation with the Royal Canadian Mounted Police (RCMP) Halifax District, Musquodoboit Harbour Office and the Provincial Department of Natural Resources (DNR).

This partnership was organized to address the need for volunteers to assist the RCMP and DNR by patrolling off-road areas. Volunteers make observations, check cottages and camps and report questionable conduct and activity to the appropriate authorities.

COP-OR is not an enforcement group and have no police powers. Our primary goal is to promote safe and responsible recreational use of off- highway vehicles and to protect private property.

## What we do

COP-OR patrol the abandon railway lines and other busy trails, including cottage developments. Patrollers travel in pairs or with RCMP or DNR officers.



## How to join

We are always looking for volunteers to join our group of citizens dedicated to Off-Road safety. There are a few requirements to join the COP-OR group:

- RCMP security clearance,
- Receive provincial approved training by the RCMP and receive an RCMP identification card,
- Successful in passing the Canada Safety Council ATV Riders course,
- Have an approved safety vest with appropriate cresting and other specified equipment such as GPS, first aid and safety equipment.
