#### **Identity Fraud**

Identity theft is a growing concern of more than 73 per cent of Canadians. Eighty-five per cent of the victims are between 18 – 59 years.

If criminals obtain any document with your personal information on it, it can be used to instigate a fraud. The most common ways criminals can get your information is from apartment mailboxes, social networking websites, or through hackers.

Identity theft is usually done by a network of individuals rather than a criminal acting alone. Below are eight tips to protect yourself from identity fraud:

- Never leave loose credit or debit card receipts in the car
- Never leave your cell phone or lap top in your car
- Update security and virus protection on your home computer
- Change your PIN, especially if you have been using the same one for a few years
- Purchase a shredder
- Request a personal credit report
- Never provide your social insurance number on credit applications
- Never carry your birth certificate in your wallet

As soon as new members are security cleared let Ray Brown, the ACOPA ID person, know the names and the group and he will issue the ID card along with the A.C.O.P.A. number.




#### 2014 AGM & Workshop

## **ALL YOU WANT TO KNOW ABOUT INSURANCE**



Insurance questions are the most asked questions from C.O.P. groups. If you have any insurance related questions, please contact Eugene Smereka at: insurance@acopa.ca

We will attempt to set your minds at ease with the following information:

#### What does it cover?

A Liability policy is a policy designed to protect the insured from the risks of liabilities imposed by law. It protects the insured in the event they are sued for claims that come within the coverage of the insurance policy. Liability insurance offers specific protection against third party insurance claims, i.e., compensation for someone suffering loss who is not a party to the insurance contract. When a claim is made, the insurer has the duty and right to defend the insured

#### Who make the claim?

You will submit the statement of Claim to us once you have been served with the papers from the injured party's lawyers.

#### Does it affect our personal insurance?

No, our liability policy is a separate policy and has no effect on your personal insurance.

## If we don't take out the insurance will our own personal insurance on our cars cover if we get in an accident?

The liability policy you purchase through Jubilee is not an auto policy; it is a Commercial General Liability policy. If you use your personal auto while on duty for the COP you will need to let you auto broker know that you are now using your vehicle for this purpose. If you are in an accident with your vehicle, your auto policy is the first to respond to the claim. If your auto liability limits are exhausted meaning the judgement is greater than the limit of liability that you carry then the General Liability policy carried through the COP program in our office will respond to the remaining portion of the claim.

## Does it cover if we get hurt or we hurt someone else? (Self defense, car accident...etc.)

We have two policies under the COP program. One is the General Liability Policy that provides coverage for you if you are sued by and injured personal where you are held legally liable. The other policy we offer is an Accidental Death & Dismemberment policy that will provide coverage for you if you are injured or killed while on duty.

#### When does the term start?

Both start November 1<sup>st</sup>

#### What is the cost?

Liability Insurance is Accidental Death and Dismemberment

\$206 per year up to age 70 \$256 per year up to age 80

No coverage for over age 80

#### Where do we purchase the insurance?

You need to make application to:

#### What about special events?

Volunteer groups are permitted to host 3 special events per year where the events may involve alcohol and where there are less than 150 people in attendance. If a volunteer group hosts more than 3 special events in a year where alcohol is served, then there will be an insurance fee of \$188 applied to the event. Or, if there are more than 150 people in attendance at the event where alcohol is served, then the insurance fee of \$188 will apply.

## What does the Insurance provider require in order for a COP group to qualify for Liability Insurance?

A C.O.P. group is required to be registered as either a Society or an Association through Alberta Registries. The C.O.P. group is required to provide a copy of the certificate of Incorporation to the ACOPA Treasurer who will forward to the Insurance provider.

## Should all volunteers with Citizens On Patrol be covered by their own personal insurance?

Yes, all volunteers should be covered by their own personal insurance.

#### Are there any special incentives to reduce the Insurance rate?

Yes, if all the members of a C.O.P. group agree to follow the recommendations that are outlined in the A.C.O.P.A. Reference Manual to the best of their ability, and sign a Statement of Intent saying that the group agrees to follow the recommendations, then the group is eligible to receive a 5% reduction in the cost of the Liability Insurance. The form must be signed and received by the ACOPA Treasurer by September 1<sup>st</sup> of each year. The form must be signed each year in order to qualify for the reduced insurance rate.

## What about special events that the C.O.P. group decides to participate in, such as offer assistance with parades, shredding events, New Year's Eve festivities, etc..?

If a group decides to participate in special events such as mentioned, the members should have agreed to such involvement, there should be a motion made at a meeting and a written record stating that the members will participate in the special event at the date so written.
